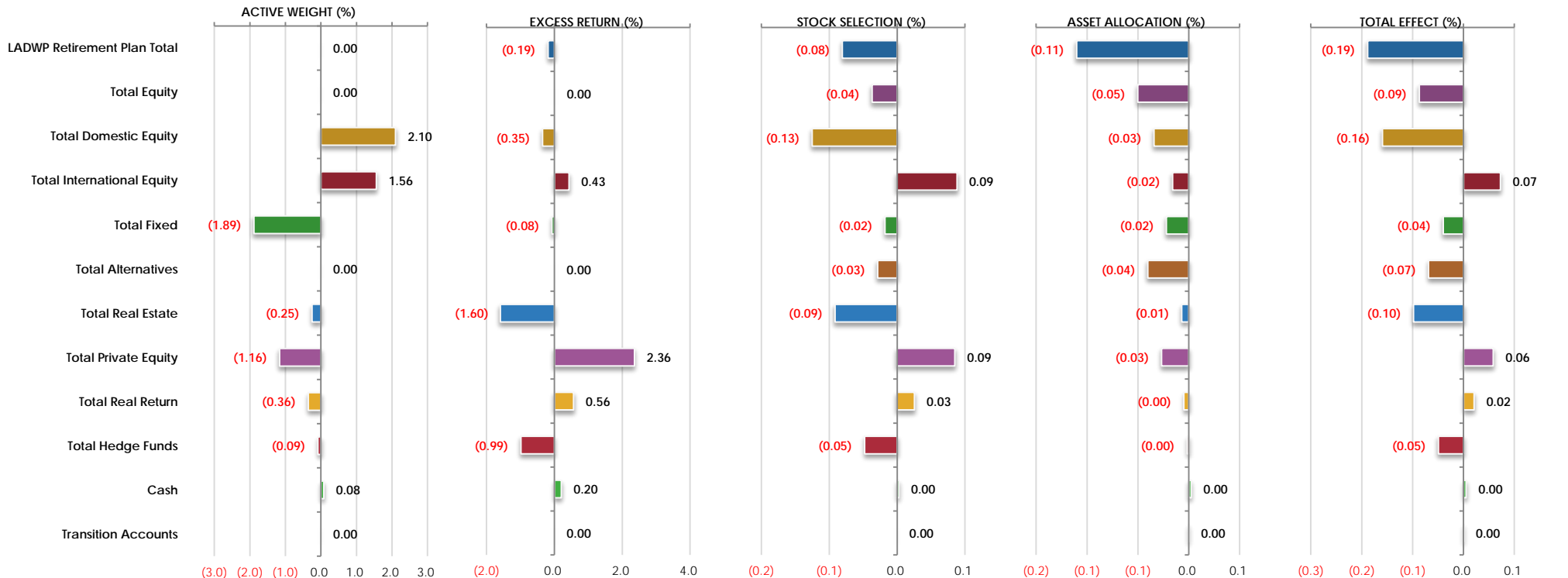

Plan Level Attribution - 1 Month



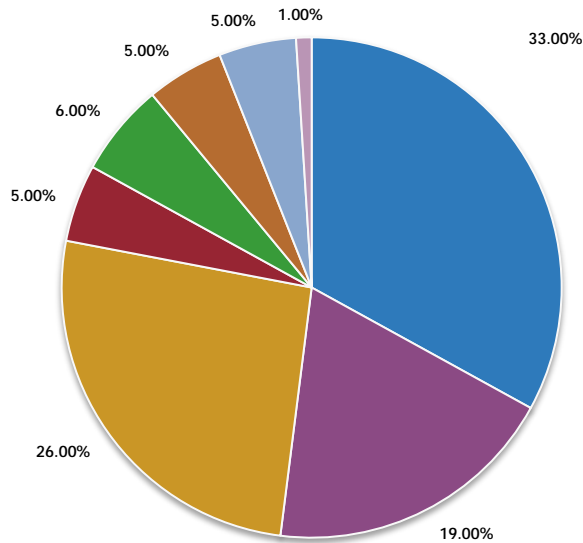

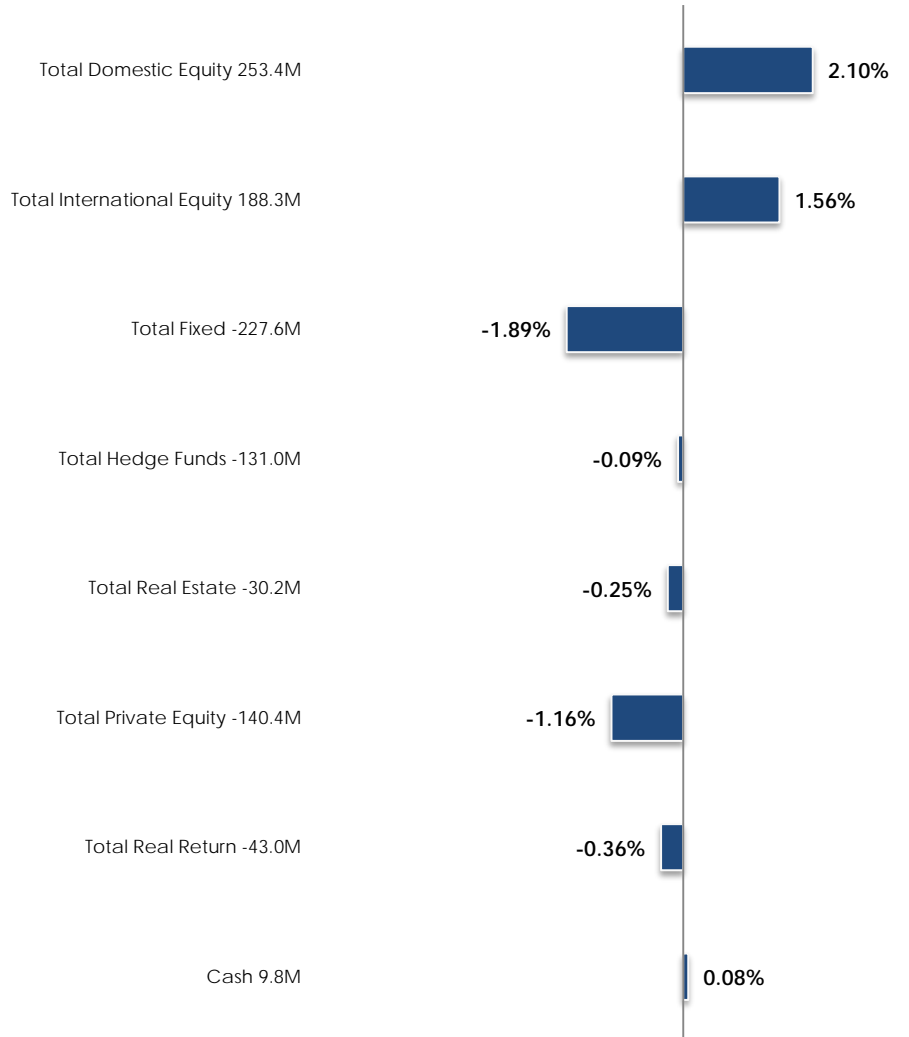

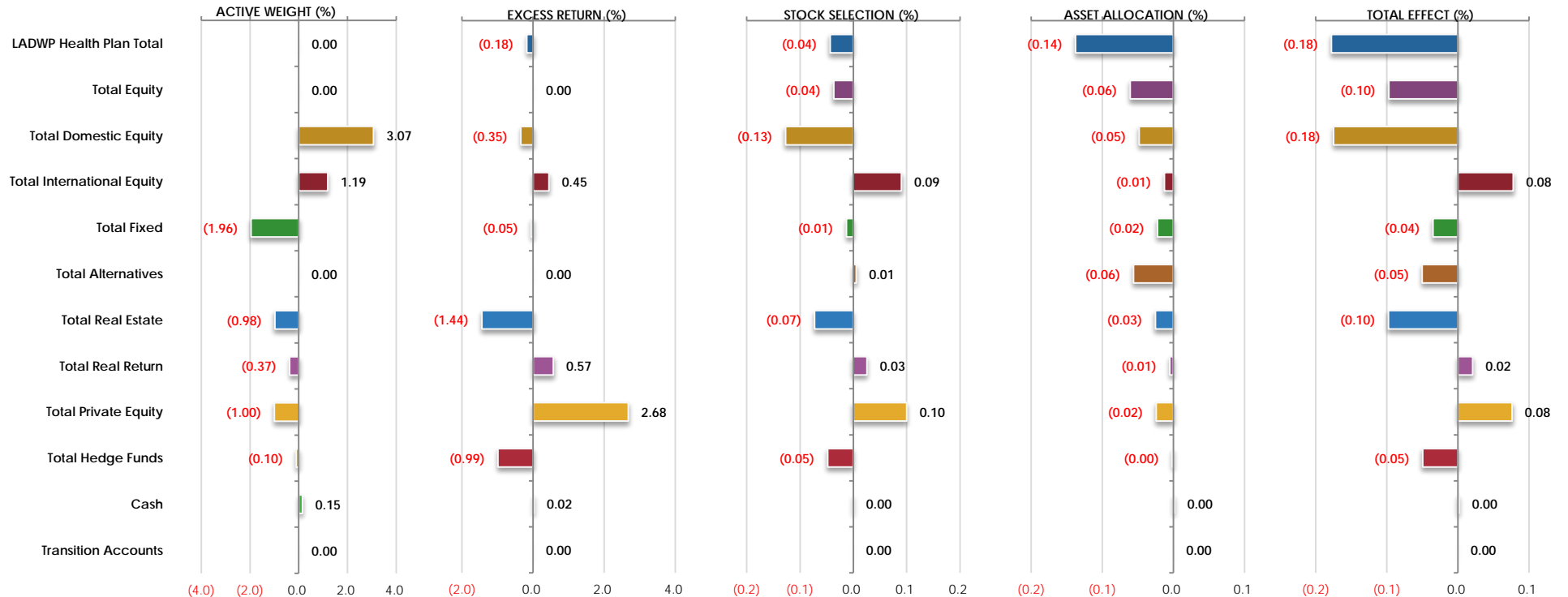

Plan Level Attribution - 1 Month



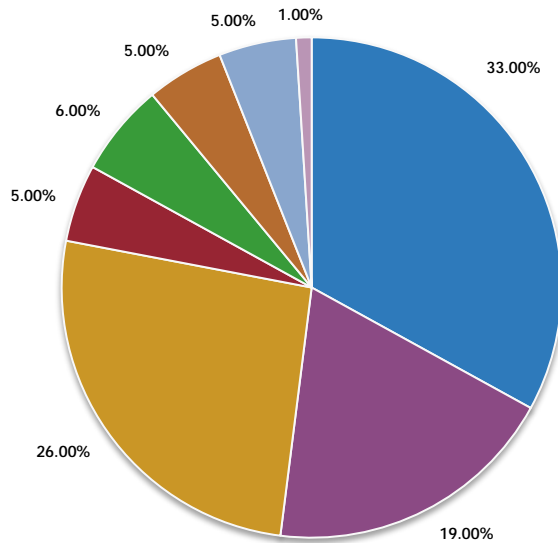

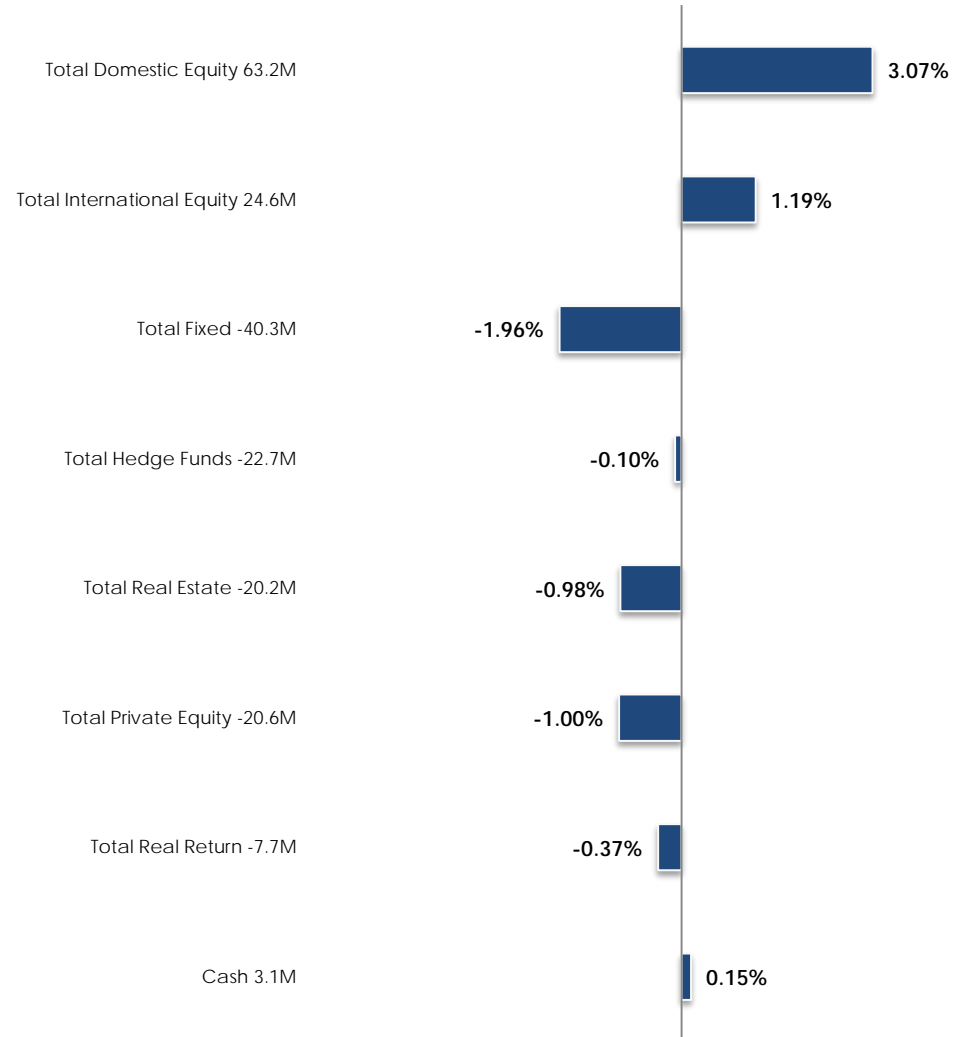
