At its January 17, 2007 meeting, the Board approved the extension of the contract with Investment Manager, Invesco Global Asset Management, Inc. (Invesco). Invesco has managed an international equity mandate since June 2004. The firm has delivered a 20.56% annualized return since inception of the contract in 2004.
