Please be reminded that the December 2008 retirement checks will be payable on January 2, 2009.

### **2008 1099R's:**

The Retirement Office is currently processing your 2008 1099R's and they will be mailed by January 30, 2009. If you have changed your address since November 30, 2008, please contact the Retirement Plan Office to update your information to avoid any delays in receiving your 2008 1099R. Please note that similar to retirement checks, 1099R's with incorrect addresses are returned to the Retirement Plan Office.

### **DIRECT DEPOSIT:**

Electronic Direct Deposit (EDD) is a convenient way to avoid any delays in the receipt of your monthly retirement allowance. If you have not signed up to have your check deposited directly into your bank account, please contact the Retirement Plan Office. EDD is safe, convenient, and you will receive a monthly statement of the deposit, including all year-to-date information.
