#### **News from the Board of Administration:**

At its December 6, 2006 meeting, the Board interviewed five conservative fund of hedge funds managers and selected Aetos and PAAMCO to handle hedge fund investments in the amount of approximately \$69 million. These funds are an alternative investment which will help diversify the Plan's portfolio.

The Board sent a letter to the Office of the Mayor in response to concerns expressed regarding investments in companies that have business operations in Sudan. The letter informed the Mayor that the Plan has approximately \$2 million worth of exposure to four companies. In addition, the Board approved the letter to be sent to the Plan's investment managers and to companies requesting information about the nature of their business operations in Sudan.

At the Board's December 20, 2006 meeting, Pension Consulting Alliance (PCA) presented the Quarterly Performance Review (Review) as of September 30, 2006. The Review stated that the Plan's total portfolio, as of 9/30/06, was valued at \$6.7 billion, representing a \$216.2 million increase in value over last quarter. For the latest quarter, the Plan's investment portfolio returned 4.0%, slightly below its benchmark return of 4.2%.
