News from the Board of Administration:

Asset Liability Study

We reported previously that the Board retained PCA/EFI to conduct an asset liability study for both the Retirement Plan and the Retiree Healthcare Fund. At the meeting of May 2, 2007, the Board discussed the possibility of special meetings for these presentations.

Fixed Income Managers

The Board approved a resolution to extend the contracts of their fixed income investment managers, ING, and Wells Capital, for a three year period ending June 30, 2010 after considering PCA's recommendation and the report from staff.

Audit Committee

On May 16, 2007, the Audit Committee of the Retirement Board interviewed actuarial firms, Buck Consultants and The Segal Company, in connection with the selection of an actuary for the Plan. The Audit Committee will submit its recommendation to the full Board at the meeting of June 6, 2007.

Quarterly Performance Review

At the regular meeting of the Board on May 16, 2007, the Plan's investment consultant, PCA, presented the quarterly performance review as of March 31, 2007. As of March 31, 2007, the Retirement portfolio was valued at \$7.2 billion representing a \$100 million increase in value over the last quarter. The investment portfolio returned 2% and kept pace with its policy benchmark during the last quarter.
