News from the Board of Administration:

At its meeting of October 3, 2007, the Board's actuary, Buck Consultants, presented a report detailing the annual actuarial valuation of the Retirement Fund as of June 30,2007. The main purpose of this report is to determine how much the Department will have to contribute to the Water and Power Employee's Retirement Plan for the next year. The Department's contribution for the year 2007 was determined to be 21.59% of payroll or approximately \$144 million per year. Another key finding of the valuation showed that the Retirement Plan's funded ratio had increased from 91.5% to 91.9% in 2007. This means the Plan continues to be well-funded.

The Retirement Office received several calls and e-mails that the October newsletter was not received until the week of October 15th. We apologize for the delay in the distribution of the newsletter.
