## News from the Board of Administration:

#### Discretionary Cost of Living Allowance (COLA)

Plan provisions require the Board to review the status of COLA banks periodically and gives it the authority to provide a discretionary/ad hoc COLA within certain limits. Accordingly, the Board requested an actuarial study. The study included different options for and the actuarial costs of each option. At its meeting of April 16, 2008, the Retirement Board voted to provide a discretionary/ad hoc COLA of up to 4.133%, depending on the member's retirement effective date.

The purpose of this ad hoc COLA is to restore lost purchasing power to retirees and survivors who have been retired the longest. The option selected by the Board will restore purchasing power to 90% for members who retired on or prior to July 1, 1979. Approximately 1,200 members will qualify to receive this discretionary COLA. Members who retired on or after July 2, 1979, will not receive an ad hoc increase because they have maintained at least 90% of purchasing power. Eligible retirees will receive this ad hoc COLA effective July 1, 2008. The ad hoc COLA is over and above the maximum 3% COLA adjustment previously approved for all retirees and survivors that will also take effect July 1st.
