Dear Fellow Plan Members,

As your Joint System Representative since August 2013 and Board President since July 2018, I have been proud to serve on the Retirement Board on our behalf.

When I first joined the Retirement Board, our Retirement Fund had a market value of \$12.6 billion. Today, that amount has grown to \$16.4 billion, an increase of \$3.8 billion in just 10 years. More importantly, our funding ratio has grown to 96.58%, ensuring stability and longevity for our benefits.

Besides improving our funding, the Retirement Board has made improvements to the Plan and our operations to better provide for you. The list of improvements is long, so I wanted to focus on a few highlights:

 A Bereavement Counselor has been appointed to help your family navigate the DWP and its entities should you pass away;

Know your Benefits

Did you know that your retirement plan protects your beneficiaries after your death? Benefits are available to you while in active service and as a retiree.

Death after Retirement

- 14 times your Option Full monthly retirement allowance (up to \$20,000 maximum).
- A refund of your employee contributions and interest (Only applicable if you selected Option A at the time of retirement).
- Any accrued retirement benefits (if applicable).
- A monthly spousal benefit if you had an Eligible Spouse or Registered Domestic Partner at retirement.

Never give out your Social Security Number, login credentials, or any other personal information. **Water and Power Community Credit Union** will never call, email, or text you and ask for this information.

If you suspect you're the victim of fraud, call us immediately at 213-580-1600.

Protect yourself against scams!

Remember, legitimate agencies never demand payments over the phone, or pressure you to make payments right away, or threaten you if you don't agree to pay. Do not hesitate to refuse to give information or tell them you will call back, then you can check the validity of any phone number you are provided.

If the Retirement Plan Office calls you, we will identify ourselves and never request payment. We may ask some information to verify your identity, but will not ask for the full number, such as Social Security number, birthdate or address. Our questions vary so that a scammer cannot prepare answers in advance. If we have any concerns, we may call back another day or ask you to visit our office. If you have concerns, always call the number published in the newsletter or check our website. Better yet, come visit us in person.
